

# Terms of Use

9 March 2022

World Anti-Doping Agency Version 1.0



These terms of use (**Terms**) form an agreement between WADA and any user (**you**) of the following website (<a href="https://wadasymposium.org/">https://wadasymposium.org/</a>) and the Delegate App (the "App" and collectively with the website, the "Symposium Online Tools", in connection with the 2022 WADA Annual Symposium (the "Symposium").

These Terms govern your use of the Symposium Online Tools through any means, including web and mobile.

You must read and review these Terms and the Symposium <u>Privacy Policy</u> carefully before activating your account and using the Symposium Online Tools. By using the Symposium Online Tools, you agree to these Terms and acknowledge that you have read and understood the Symposium Privacy Policy, in each case as updated from time to time.

We reserve the right to change these Terms, or any aspect of the Symposium Online Tools including their features and functionality from time to time. We will post the latest version of these Terms on the Symposium Online Tools and will display the date of each version's publication on this page.

## Accounts and Security

You are responsible for maintaining the confidentiality of your username, password and account, and for taking reasonable precautions to prevent the inadvertent or unauthorized disclosure or loss of your username, password or account information.

You agree to notify WADA immediately of any unauthorized use of your account or any other breach of security relating to the Symposium Online Tools of which you are aware.

## Access to the Symposium Online Tools

WADA will use reasonable efforts to make the Symposium Online Tools available but does not guarantee that access to the Symposium Online Tools will be uninterrupted or error free. WADA may at any time suspend or terminate access to the Symposium Online Tools, or modify or discontinue any feature of the Symposium Online Tools without liability to you for any reason, including for security and maintenance purposes or for a violation of these Terms.

# Licence to use the Symposium Online Tools

Subject to your compliance with these Terms, WADA grants you a limited, non-exclusive, revocable, non-transferrable and non-sublicensable license to access and use the Symposium Online Tools for personal, non-commercial informative purposes only.



## No unlawful or Prohibited Use

You will not use the Symposium Online Tools in violation of these Terms or of any applicable law. Without limiting the generality of the foregoing, You will not and will not attempt to:

- send, upload, collect, transmit, store use, post, publish or otherwise communicate any data, information, pictures, video, audio or other materials or content that:
  - contains any computer viruses, worms, malicious code, or any software intended to damage or alter a computer system or data;
  - you do not have the lawful right to send, upload, collect, transmit, store use, post, publish or otherwise communicate;
  - is false, intentionally misleading, or impersonates any other person;
  - is defamatory, bullying, harassing, abusive, threatening, vulgar, obscene, or offensive, or that contains pornography, nudity, or graphic or gratuitous violence, or that promotes violence, racism, discrimination, bigotry, hatred, or physical harm of any kind against any group or individual:

## General

#### Termination

WADA may terminate these Terms at any time with immediate effect in the event of a breach of these Terms or if we choose, in our sole discretion, to cease to provide the Symposium Online Tools (in whole or in part). We will use reasonable efforts to notify you of any such action. You may terminate these Terms at any time by ceasing your use of the Symposium Online Tools.

#### <u>Survival</u>

In the event these Terms terminate, the paragraphs regarding Intellectual Property, Disclaimers and Limitation of Liability, Indemnity, Third-Party Terms and General and any other terms which by their nature survive termination, shall survive termination.

#### Severability

If any provision of these Terms is determined by any competent authority to be void, invalid, unlawful or unenforceable to any extent, provision will to that extent be severed from the remaining Terms, which will remain in full force and effect.

#### Third Party Rights

Other than as provided for in the "Third-Party Terms" section, no person other than you or WADA may enforce these Terms.

#### **Entire Agreement**

These Terms and all other legal notices or statements posted on the Symposium Online Tools constitute the entire agreement between WADA and you with respect to the use of the Symposium Online Tools.

#### Choice of Law and Disputes

Except where restricted or prohibited by applicable law of your domicile, residency or physical location, your use of the Symposium Online Tools and these Terms will be governed by the laws of Switzerland, with the exclusion of its principles of conflicts of laws; and any dispute arising from or related to the use of the Symposium Online Tools or these Terms shall be submitted exclusively to the Court of Arbitration for Sport in Lausanne, Switzerland, and resolved in accordance with the Code of sports-related arbitration.
