Overview of ADEL

The World Anti-Doping Agency (WADA)'s Anti-Doping Education and Learning platform (ADEL) is the centralized platform primarily offering educational solutions for Anti-Doping Organizations (ADOs) to complement or use in their education programs or to extend the reach of their existing education programs. Our education solutions available on ADEL include courses, programs and resources for athletes, coaches, medical professionals, researchers, and other target audiences as identified in the World Anti-Doping Code (Code) and the International Standard for Education (ISE).

Additionally, on ADEL, anti-doping practitioners will be able to access learning opportunities such as training programs to help them carry out their roles through the Global Learning and Development Framework (GLDF); and a wide range of digital resources to support the development of their anti-doping programs through the Code Implementation Support Program (CISP).

The use and access to ADEL is free with the objective to maximize the reach of, and access to, quality education and learning opportunities to benefit all audiences, especially those working in or supporting the goal of clean sport. ADEL is for everyone, and anyone interested in learning more about anti-doping and protecting the values of clean sport. ADEL is available 24/7 with stable connection to internet. The 'ADEL by WADA' mobile app is available on the Apple Store and Google Play store, enabling users to learn on the go and complete their education offline.

ADEL Version 2

On 6 January 2021, WADA launched a new and improved ADEL, which replaced the previous Anti-Doping eLearning platform (ADeL) launched originally in January 2018.

It is important to highlight that the original ADeL platform had to be rebuilt largely due to discontinued security protocols putting WADA's users at risk. After months of research and discussion with various internal and external stakeholders, WADA's Education department made the decision to move to an industry leading Learning Management System provider and rebuild the platform. This change supports both WADA's new strategic direction (Grow Impact and Be Athlete-Centred through digital transformation) as well as the future demands required to effectively provide support to ADOs to enable them to meet the requirements of the ISE as well as the Code and other International Standards.

ADEL (v2) is efficient in managing learning including learner data and reporting, enables users to be self enrolled to programs and to receive certificates, allows trainer-led sessions, eLearning programs and digital resources to be hosted and delivered, has a modernized look and feel with human focused graphic visuals to



better resonate with athletes and the clean sport community. To improve efficiency and service to our end users, a dedicated ADEL Helpdesk system with instructional articles to help users solve common issues (signin and navigation) is present, as well as a dedicated place for Anti-Doping Organizations to request translations of education programs or to become administrators (known as ADEL Power Users) of their populations.

Lastly, we made a commitment to publish ADEL materials in English, French and Spanish to better meet the needs of our stakeholders.

Anti-Doping Organizations (ADO) Capability

ADEL offers solutions to anti-doping practitioners with a view to strengthen their capability, through resources that support the development of their anti-doping programs, their implementation of the World Anti-Doping Code and International Standards and their own professional development.

Code Implementation Support Program (CISP)

The Code Implementation Support Program (CISP) hosted on ADEL provides guidance, support, and resources to assist ADOs in their implementation of the 2021 Code and International Standards and the development of their anti-doping programs. It currently includes more than 300 resources, including factsheets, video tutorials, checklists, presentations, recorded webinars, and templates with the majority available in English, French, and Spanish. Since the launch on the new ADEL, the program experienced more than 18,643 interactions/views by a little more than 2,000 active ADO practitioners, which means on average seven (7) resources viewed by one practitioner. This highlights the demand from practitioners to access helpful resources, available digitally and that can be downloaded at any time, to support them in their work. It is noteworthy that CISP was launched in May 2020 on the previous version of ADeL, in total there have been approximately 37,643 interactions with the program.

CISP Resources

A total of 54 resources were published in 2022 on this CISP Channel. Many of the resources have been translated into French and Spanish. 11 of these are webinar presentations and recordings, together with 25 templates, 8 guidelines, 4 factsheets, 1 checklist, 2 how-to guides, and 3 curriculums. The Global Learning and Development Framework (GLDF)

As part of WADAs 2020-2024 <u>Strategic Plan</u>, the Global Learning and Development Framework (GLDF) was created in April 2020 to support the 'Grow Impact' priority under the Strategic Plan. The GLDF develops professional standards for a range of anti-doping roles and provides specific, standardized training as well as continuous professional development (CPD) opportunities to anti-doping practitioners worldwide, to improve professionalism and enhance the capabilities of the anti-doping workforce.

Although the GLDF training programs were originally intended to be delivered in-person, they were successfully moved to a virtual format due to the COVID-19 pandemic and fully hosted on ADEL. GLDF offers role-specific training programs spanning over the course of 9-15 weeks (depending on the role), with an expected commitment of 3 hours on average of learning per week. The learning journey adopts a blended format, incorporating self-directed eLearning, trainer-led sessions and individual 1:1 mentoring sessions. Due

to the virtual nature of delivery and to ensure personal learning needs are still met, each training cohort is limited to a maximum of 16 participants, who are invited by WADA to take part in the training program.

In 2022, GLDF had 6 training programs on offer, covering the following roles:

- Education
- Results Management, including Hearing Panel members
- Intelligence and Investigations
- Privacy and Data Protection
- Media Relations and Communications
- Therapeutic Use Exemption (TUE) and TUE Committee.

The ADEL platform has the features and functions to support the delivery and implementation of the GLDF program. The ADO practitioners who have enrolled in the training program have access to a different landing page. There is a dedicated area (called My GLDF Training Program) on their landing dashboard to access their training program. For each of the roles identified, a designated channel is created to host all the training program content.

- For the e-learning courses of each role, participants always have access to the courses and a soft deadline is enabled to prompt completion before the trainer-led sessions.
- For trainer-led sessions, an initial enrollment notification with a calendar invitation and a pre-session notification are enabled as reminders for participants.




Figure 1: My GLDF Training Program space (Jan. 2023)

Groups

 - Resources to educate athletes and ASPs on TUEs






Figure 2: RADO Channel Overview (Jan. 2023)

- To support the Athlete Biological Passport (ABP) function activities, a number of live sessions were offered

to support the ABP experts and the Athlete Passport Management Units (APMUs):

- ABP Experts channel designed for experts involved in the haematological module of the ABP. In this channel, two webinars were hosted in 2022, discussing a case and presenting a paper.
- APMU channel designed for people working within WADA approved Athlete Passport Management Units (APMUs). In 2022, an e-learning ABP expert guide was made available on this channel and a series of three webinars were hosted:
- The roles of the ABP partners and APMU requirements
- Description of the Adaptive Model
- ADAMS and APMU activities.




Figure 3: ADO Signatories as ADEL Power Users

ADEL Statistics

This section provides the statistics as it relates to users on the ADEL platform and the number of course

completions per education program/resource for the year 2022.

Platform User Statistics

The table below provides the monthly active user count and the total number of unique active users who have accessed ADEL since the launch on 6 January 2021 up to and including 31 December 2022. During the two-year period of 2021–2022, ADEL was used by more than 163k users from 234 countries who participate in 222 different sports. Compared with the previous year, 2022 has seen an increase in number in 3 aspects:

- 1. Number of underdeveloped countries and regions coming to ADEL for the first time
- 2. Number of users coming from underdeveloped countries and regions
- 3. Number of sports

When ADEL was initially launched, the monthly active user count was estimated at 3500, and it has been on the rise since. A monthly average of 5000 active users was attained in September 2021. Between October 2021 and September 2022, ADEL sustained growth in monthly active users, reaching an average of 8000.

The table below lists the active user count per month and unique active users for each role within the clean sport community.

- Active users refer to a learner who logs into a course (and not just the ADEL platform) during the 30day month period. It is possible that the same learner stays active in multiple months and is counted more than once.
- Unique active users refer to learners who have accessed the platform since the ADEL launch and are counted only once.




Figure 4: Top 10 countries with the highest number of users




Figure 5:Top 10 sports with the highest number of users

Education Statistics

In total, there were 394,243 completions of education courses and programs by all ADEL users since the launch, not including WADA staff using the sub-domain WADA Learning Path.

- A completion means the learner has met all the requirements of a course, for example:
 - Reviewed all pages in a guide document
 - Completed all the modules within an education course
 - Completed all the courses within an education program

 With the total completion count a lot higher than the number of total unique users, it shows that users have completed more than one course or, in some cases, completed all necessary requirements to obtain certification of completion.

ADEL in 2023

Front-line Education Solutions Content Development Plan

The Guidelines for the International Standard of Education state that education should be ongoing and structured according to each development stage along the athlete pathway. Additionally, the people surrounding athletes (ASP) have direct impact on athletes' behaviors and need to be educated to build a strong system to protect clean athletes.

In line with the ISE, WADA will further develop education programs in 2023 to enable ADO practitioners to complement or use for educating the athletes and ASPs in their education pool:

- ADEL for Talented Athletes competing internationally
- ADEL for Youth Athletes
- ADEL for Recreational Athletes
- ADEL for Club or Community Coaches
- ADEL for Medical Professionals (revamp)
- Guide to the List 2024
- ADEL Refresher Course for Coaches of High-Performance Athletes (Recertification)

Translations

Equally important, we are working to help ADOs extend the reach of their education programs by offering translation support and service. The following languages listed below are planned for translation:

- ADEL for International Level Athletes Education Program (Arabic International, Burmese, Chinese Traditional, Hindu, Lao, Malaysian, Mongolian, Russian, Serbian, Turkmenistan, Uzbekistan, Vietnamese)
- ADEL for Coaches of High-Performance Education Program (Czech, Japanese, Portuguese, Tagalog, Thai)
- ADEL for Talented Level Athletes Education Program (Bulgarian, Japanese, Tagalog)
- At a glance series (Croatian, Ukrainian, Portuguese)

In support of upcoming major events (the Asian Games, the 2024 Winter Youth Olympics, the Paris 2024 Olympics, and Paralympics Games), WADA Education team will actively collaborate with ADOs on the



translation of relevant pre-Games education courses, to make them accessible for the athletes and ASPs going to the games.

Pre-Games Education

With Olympics (Tokyo summer Olympics and Beijing winter Olympics) pre-Games education a success in terms of the high level of athletes and coaches' participation and completion, we are working to build our partnership with the IOC to develop anti-doping education solutions for athletes and ASP going to the 2024 Paris Olympics and Paralympics Games. The following pre-Games education courses are planned to launch this year:

- ADEL for Paris 2024 Olympics
- ADEL for Paris 2024 Paralympics

ADEL Landing Dashboards

With more and more education solutions made available, including in many languages on ADEL, WADA aims to improve learners' experience in terms of navigation. ADEL Roadmap

WADA aims to inform the anti-doping community about new programs and resources being developed, in what languages and approximate timeline. For ADO practitioners only, there is a dedicated page called <u>ADEL</u> <u>Roadmap</u> on the ADO Zone dashboard. WADA aims to update the information on a regular basis so ADOs are aware.

ADO Capability

Communities of Learning

The Communities of Learning (CoL) refer to the growing pools of participants' cohorts who have gone through role-specific training, and for which the GLDF provides a platform for continuous professional development (CPD) opportunities. Their activities, which will be launched in 2023, will be hosted on ADEL.

CPD opportunities for CoL will be of two kinds some role-related, others covering the core competencies that are common across the various roles in the industry.

- Role specific CPD: Just like the development of GLDF role-specific training has been informed by the role-specific professional standard (a document benchmarking good professional practice), role specific CPD activities are mapped against these standards. The 2023 launch of these CPD activities will take the form of "Ask the Expert sessions", which will offer participants the opportunity to delve deeper into some of the topics of the role-specific trainer curricula.
- Generic anti-doping practitioner CPD: A key document of the GLDF is the anti-doping core competency framework (CCF). The CCF details the values that should guide and influence all practitioners across the industry in their actions and in the choices that they make as well as the competencies that are common across the various roles in the anti-doping industry, and that all practitioners should be able to demonstrate. The CoL will offer CPD activities that were designed to

develop and strengthen these core competencies. The 2023 launch of these CPD activities will be of two kinds:

- Scenario Based Learning. Through facilitated discussions (by GLDF Trainers), up to 16 participants will be invited to share their opinions, perspectives, and personal experiences in given scenarios, exploring together the key behaviours for success in a given area.
- A curated library of online courses which will offer participants open access to a range of generic videos, PDFs and word documents with high quality informative content on good practice. This library of information developed by specialists is accessible at any time for all anti-doping practitioners and organized around the 7 core competencies of the CCF.

Testing training program

A GLDF training program has been developed early 2023 and currently being piloted. Once evaluated and revised, this training program will be added as a seventh role to the GLDF training programs' offer.
